Description (material/optics)/ analogue items :

Cookware set consists of low casserole Ø 20cm with lid, high casserole Ø 20cm + 24cm with lids and saucepan Ø16 cm with lid: Pot made of special steel with ceramic coating, with chromed rim and handles made of stainless steel. Glass lid with rim made of stainless steel and handle made of stainless steel.

When used as specified, the transition of substances does not exceed the legal limits and the SRLs (Specific Release Limits) according to Council of Europe Resolution CM/Res(2013)9 on metals and alloys used in food contact materials and articles (effective 2013 – 1st Edition).

The tests are performed according to the Directive 84/500/EEC, last amended by 2005/31/EC, respectively according to the „Technical guide on metals and alloys used in food contact materials and articles “. The test for enamel was performed according to the standard DIN EN ISO 4531.

repeated contact, short-time also above 100°C

- Ratio of the area of the food contact surface to the volume used to determine the compliance of the food contact material or article made from metal:

1,3 dm<sup>2</sup>/ L
