Pot made of special steel with ceramic coating, with chromed rim and handles made of stainless steel. Glass lid with rim and handle made of stainless steel. Item No. 05.1565.5290

When used as specified, the transition of substances does not exceed the legal limits and the SRLs (Specific Release Limits) according to Council of Europe Resolution CM/Res(2013)9 on metals and alloys used in food contact materials and articles (effective 2013 – 1st Edition).

repeated contact, short-time also above 100°C

- Ratio of the area of the food contact surface to the volume used to determine the compliance of the food contact material or article made from metal:

5,9 dm²/ L
