

Declaration of Compliance

for articles made from metals and alloys intended to come into contact with food

Hereby we confirm that our product:

Item name: Tea/ herb infuser "Gourmet" Ø 6,5cm Item No.: 06.4268.6040

complies with the legal regulations laid down in the German Commodity Ordinance, the Regulation (EC) No 1935/2004 and the Regulation (EC) No 2023/2006, in their relevant versions.

Description (material/optics): fabric border, link to half pellet, hook, chain and carbine are made of polished, stainless steel (Cromargan® 18/10), rivet is made of Aluminum, sieve fabric is made of Mn-Austenite, Ø 6,5cm.

When used as specified, the transition of substances does not exceed the legal limits (Specific Release Limits – SRL) according to Council of Europe Resolution CM/Res(2013)9 on metals and alloys used in food contact materials and articles (effective 2013 – 1st Edition). The test was performed according to the „Technical guide on metals and alloys used in food contact materials and articles“.

Specification of the intended use or limitations:

- Type (s) of food intended to come into contact with the material:

Tea, water (oily, acid and aqueous)

- Intended duration and temperature of treatment and storage while in contact with the food:

Repeated short- term contact with temperatures up to 100°C,

respectively test conditions of the laboratory (Simulant, duration, temperature of the contact):

2 hours up to 100°C

- Ratio of the area of the food contact surface to the volume used to determine the compliance of the food contact material or article:

6 dm²/kg
