## Declaration of Compliance

for materials made from plastic intended to come into contact with food

Hereby we confirm that our product

### Saltrunner Item No. 06.5589.7620

complies with the legal regulations laid down in the German Commodity Ordinance (or the respective stipulations laid down in the European Regulations on Plastic materials) as well as Regulation (EU) No10/2011, the Regulation (EC) No1935/2004 and the Regulation (EC) No 2023/2006, in their relevant versions.

Description (material): Body, wheels, wheel cover plastic (ABS - acrylonitrile butadiene styrene), container (PP - polypropylene), head (ABS - acrylonitrile butadiene styrene, TPE - thermoplastic elastomer); tires (EPDM - ethylene-propylene-diene polymerisation kautschuk), axis/screws carbon steel, nickel plated, gear carbon steel zinc-plated, plastic (POM-polyoxymethylene)

When used as specified, the overall migration as well as the specific migration do not exceed the legal limits. The test was performed according to the Directives 82/711/EEC and 85/572/EEC.

The materials and raw materials used comply with the German Commodity Ordinance (or the respective stipulations laid down in the European Regulation (EC) No1935/2004 and the Regulation (EU) No 10/2011, respectively according to the latest version.
