Hereby we confirm that our product:

Description (material/optics): Container is made of ceramic, spout is made of stainless steel (Cromargan 18/10) with silicone gasket, lid is made of stainless steel (Cromargan 18/10)

When used as specified, the transition of substances does not exceed the legal limits and the SRLs (Specific Release Limits) according to Council of Europe Resolution CM/Res(2013)9 on metals and alloys used in food contact materials and articles (effective 2013 – 1st Edition).
