

## Declaration of Compliance

**for articles made with plastic and ceramic intended to come into contact with food**

Hereby we confirm that our product:

### **Electric tilt mill Item No.: 06.6734.6030**

complies with the legal regulations laid down in the German Commodity Ordinance (or the respective stipulations laid down in the European Regulations on Plastic materials) as well as Regulation (EU) No 10/2011, the Regulation (EC) No 1935/2004 and the Regulation (EC) No 2023/2006, in their relevant versions.

Description (material/optics): the container is made of Polymethylmethacrylate (PMAA), spring, base and top part of mill, treaded insert wing and supporting disc are made of stainless steel (Cromargan® 18/10), Insert of top part, Insert on both sides glued, distance holder, wing of fineness setting, grinding cone insert made of Acrylonitrile Butadien Styrene (ABS), axis made of aluminum, grinding cone and grinding ring are made of ceramic, washer made of Polyoxymethylene (PP), motor and battery, height 20 cm.

When used as specified, the overall migration as well as the specific migration do not exceed the legal limits. The test was performed according to the Directives 82/711/EEC, 85/572/EEC and the Directive 84/500/EEC last amended by 2005/31/EC. As from 01.01.2016 the migration tests for plastics according to articles 17 and 18 of Regulation (EU) No 10/2011 in conjunction with Annex V.

The materials and raw materials used comply with the German Commodity Ordinance (or the respective stipulations laid down in the European Regulation (EC) No 1935/2004 and the Regulation (EU) No 10/2011, respectively according to the latest version.

The following substances, subject to limitations and/or specification are used in the above mentioned product:

Dried spices (oily, acid and aqueous)

- Intended duration and temperature of treatment and storage while in contact with the food:

Repeated long-term contact with temperatures up to 40°C,  
respectively test conditions of the laboratory (Simulanz, duration, temperature of the  
contact):

10 days to 40°C

- Ratio of the area of the food contact surface to the volume used to determine the compliance of  
the food contact material or article:

6 dm<sup>2</sup>/kg

Dual-use-additives are not enclosed.

There is no functional barrier used in the plastic material.

This declaration is valid for the product delivered by us as specified above. Under consideration of the  
food contact conditions stated, the product complies with the stipulations of these Directives  
regarding the specified foods. The user shall verify himself that the product is suitable for the  
intended food beyond the stipulations of the Directives.

The validity of the declaration is ending if the requirements are changed.
