Description (material / optics) : Set with 2 low casseroles 16 and 20 cm made of Cromargan 18/10 stainless steel, 3 high casseroles 16,20 and 24 cm made of Cromargan 18/10 stainless steel, all pots with lid made of glass and Cromargan 18/10 stainless steel

When used as specified, the transition of substances does not exceed the legal limits (Specific Release Limits – SRL) according to Council of Europe Resolution CM/Res(2013)9 on metals and alloys used in food contact materials and articles (effective 2013 – 1st Edition). The test was performed according to the „Technical guide on metals and alloys used in food contact materials and articles“.

Körper/Body: 275 ml/2,36 dm² ; Deckelinnenseite/lid inner: 200ml/2,81dm²
