Description (material/optics): Set consists of one children spoon, one children fork, and one tea spoon made of polished, stainless steel (Cromargan® 18/10) and one children knife made of 1.4021; all with decor "teddy".

When used as specified, the transition of substances does not exceed the legal limits (Specific Release Limits – SRL) according to Council of Europe Resolution CM/Res(2013)9 on metals and alloys used in food contact materials and articles (effective 2013 – 1st Edition). The test was performed according to the „Technical guide on metals and alloys used in food contact materials and articles“.

Universal food (oily, acid and aqueous)

- Intended duration and temperature of treatment and storage while in contact with the food:

Repeated short-term contact with temperatures up to 70°C

829 ml/dm<sup>2</sup>
