Hereby we confirm that our product

complies with the legal regulations laid down in the German Commodity Ordinance (or the respective stipulations laid down in the European Regulations on Plastic materials) as well as Regulation (EU) No 10/2011, the Regulation (EC) No 1935/2004, in particular Article 3, 11 (5), 15 and 17, and the Regulation (EC) No 2023/2006, in their relevant versions.

Description (material/optics)/ analogue items:

Egg cup consists of blue body and board, yellow upper part, grey hair insert and glasses band, translucent insert and silver glasses made of polypropylene (PP); hammer made of grey silicone; hammer insert made of stainless steel and spoon made of Cromargan 18/10.

When used as specified, the overall migration as well as the specific migration do not exceed the legal limits; the transition of metal ions does not exceed the SRLs (Specific Release Limits) according to Council of Europe Resolution CM/Res(2013)9 on metals and alloys used in food contact materials and articles (effective 2013 – 1st Edition).

The tests are performed according to articles 17 and 18 of Regulation (EU) No 10/2011 in conjunction with Annex III and V resp. according to the "Technical guide on metals and alloys used in food contact materials and articles".

The materials and raw materials used comply with the German Commodity Ordinance (or the respective stipulations laid down in European Regulations on Plastic materials) as well as the Regulation (EC) No 1935/2004 and the Regulation (EU) No 10/2011, respectively according to the latest version. In the context of the quality assurance measures there was not found any indication of an incorrect utilization of substances evaluated.
