Description (material): Pot and Lid stainless steel polished (cromargan 18/10) with stay-cool handles, handles with red silicone

When used as specified, the overall migration as well as the specific migration do not exceed the legal limits. The test was performed according to the Directives 82/711/EEC and 85/572/EEC.
