## Declaration of Compliance

for materials made from plastic intended to come into contact with food

Hereby we confirm that our product

### Turner scoop "Black Line" Item No. 18.7546.6040

complies with the legal regulations laid down in the German Commodity Ordinance (or the respective stipulations laid down in the European Regulations on Plastic materials) as well as Regulation (EU) No10/2011, the Regulation (EC) No1935/2004 and the Regulation (EC) No 2023/2006, in their relevant versions.

Description (material): Turner scoop black (PA - polyamide), heat-resistant up to 270°C, metal stem polished stainless steel (cromargan 18/10), plastic handle „soft touch“ black (PP - polypropylene)

When used as specified, the overall migration as well as the specific migration do not exceed the legal limits. The test was performed according to the Directives 82/711/EEC and 85/572/EEC.

The materials and raw materials used comply with the German Commodity Ordinance (or the respective stipulations laid down in the European Regulation (EC) No1935/2004 and the Regulation (EU) No 10/2011, respectively according to the latest version.
