Description (material): Flexi wisk and metal stem polished stainless steel (cromargan 18/10), handle softtouch plastic (PP – polypropylene)

When used as specified, the overall migration as well as the specific migration do not exceed the legal limits. The test was performed according to the Directives 82/711/EEC and 85/572/EEC.
