Description (material): Grater polished stainless steel (cromargan 18/10), handle softtouch plastic (PP – polypropylene)

When used as specified, the overall migration as well as the specific migration do not exceed the legal limits. The test was performed according to the Directives 82/711/EEC and 85/572/EEC.

The materials and raw materials used comply with the German Commodity Ordinance (or the respective stipulations laid down in the European Regulation (EC) No1935/2004 and the Regulation (EU) No 10/2011, respectively according to the latest version.
