Description (material/optics)/ analogue items :

Two-piece Christmas tin set ø 220 mm and 170 mm made of tin sheet printed with a Christmas motif.

When used as specified, the transition of substances does not exceed the legal limits (Specific Release Limits – SRL) according to Council of Europe Resolution CM/Res(2013)9 on metals and alloys used in food contact materials and articles (effective 2013 – 1st Edition). The test was performed according to the „Technical guide on metals and alloys used in food contact materials and articles“.

6 dm<sup>2</sup>/ Kg
