Description (material/optics):

WMF cookware of the collection "Compact Cuisine" in different sizes and set compilations made of Cromargan stainless steel 18/10. Glass lids with sealing made of silicone, as well as handle and frame made of Cromargan stainless steel 18/10.

When used as specified, the transition of substances does not exceed the legal limits (Specific Release Limits – SRL) according to Council of Europe Resolution CM/Res(2013)9 on metals and alloys used in food contact materials and articles (effective 2013 – 1st Edition). The test was performed according to the „Technical guide on metals and alloys used in food contact materials and articles“.

repeated contact, cooking at elevated temperature

- Ratio of the area of the food contact surface to the volume used to determine the compliance of the food contact material or article:

2L/pot (3,0L)
